



## AGENCY AGREEMENT

- Under Section 6.6.17 of the General Terms and Conditions of American Midstream, LP's Tariff, a customer can appoint an agent and request HPGT to recognize such appointment. To submit a request, Customer must complete and return the attached Agency Request Form to AMID.
- Note that if both Customer and Agent sign, the Affidavit is not necessary and the completed form (pages 1 and 2) can be faxed to AMID at 713 815-3998. A copy signed by AMID will be faxed back to you.
- In the event that the Agent does not sign, Customer must submit the completed form as well as the notarized Affidavit. Two (2) originals must be mailed to:

### The Agency Powers American Midstream recognizes are as follows:

- Nomination agent submits nominations for you, receives final scheduled quantities and phone calls about OFOs.
- Notices agent received notices about contracts, tariff filings, etc.
- Invoice agent receives your bill for transportation services.
- Imbalance Trading agent will be able to perform imbalance trades.
- Contracts agent can request service, execute contracts and amendments on your behalf.
- Capacity Release agent can release your firm transportation and/or storage capacity and bid on capacity release offers for you. You can elect to provide the authority to bid on transportation capacity only, storage capacity only, or both types of capacity.
- Operator agent can perform confirmations, PDA setup, and review measurement for the listed locations.
