High Point Gas Transmission, LLC ("HPGT") expects capacity limitations for deliveries from VK Enterprise to HPGT Toca during the month of May 2015. The maximum available firm capacity at the MP 289 VK Enterprise meter (010034) is anticipated to be 150,000 dth/day. HPGT anticipates additional interruptible capacity MAY be available at the VK Enterprise meter depending on operating conditions during this period.

Therefore, HPGT is holding an "Open Season" for available firm transportation capacity. This open season will extend from 8 AM CDT March 12, 2015 to 5 PM CDT March 19, 2015. HPGT will award the capacity from bids received during the Open Season on the basis of net present value (NPV) determined with reference to the rate, volume, term, and the date the service is to commence. In calculating the net present value, HPGT will use the following formula.

Net Present Value (NPV) will be determined using the following formula:

NPV = En[R*(1/(1+i)**n)] where:

En = Summation of months 1 through n (Sigma)

n = term in months

R = Incremental monthly revenue

i = Monthly Discount Factor of .853 %

HPGT will have the right to aggregate bids that generate the highest net present value to HPGT.

HPGT will evaluate and rank all bids based on NPV and will award bids, best bid first, until all available capacity is awarded. In the event of a tie and unless a bidder indicates otherwise, capacity will be awarded on a pro rata basis, with all capacity being awarded to the winner(s).

Competing bids for this proposal must have identical receipt/delivery points.

Procedure:

In addition to submitting a Request for Service in accordance with Section 6.5 of HPGT's FERC Gas Tariff, Shippers will submit bids to HPGT for this FT Open Season service using the Open Season Request Form and emailing it by 5 PM CDT March 19, 2015 to the attention of Chris Whittington at cwhittington@americanmidstream.com. The forms can be found on the HPGT EBB under Customer Information/Helpful Documents/Highpoint Documents/"Open Season Offering ". Only valid requests for service under the terms of HPGT's FERC Gas Tariff will be considered. All bids will be considered binding and HPGT shall have the right to charge the winning bidder for the capacity awarded under the terms of the bid.

Shipper agrees to pay all applicable surcharges and the maximum applicable fuel and commodity charges unless otherwise specified in the bid. HPGT reserves the right not to accept bids that are at less than the maximum applicable rate.

HPGT reserves the right not to accept bids which are contingent upon the construction of facilities on HPGT's system or which are subject to any other contingencies.

Shippers should indicate in their bids the minimum volume of capacity they are willing to take in the event HPGT must prorate the bids. Shippers should indicate in their bids if their bid is contingent upon being awarded the full term of the bid or if they will accept a partial term.

HPGT will take no longer than ten (10) business days to award the bids.
